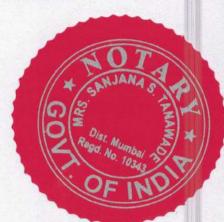

Programme:

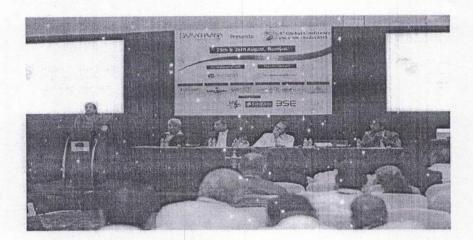
This year we once again undertook the 4th Diversity & Inclusivity along with Global Conference on Corporate Social Responsibility.

b) Basis of Accounting:

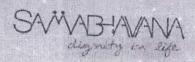
The basis of accounting is the accrual system of accounting.
